With this Clarification Text for our website visitors, in accordance with the Personal Data Protection Law No. 6698 ("**PDPL**"), we would like to inform you about the processing of personal data that is being operated and / or obtained during the operation of the Website and on the grounds that cookies are positioned by Website users / visitors; In accordance with the PDPL, we would like to inform you in order to fulfill our disclosure obligation under the PDPL regarding what types of cookies we use on the Website for what purposes and how you can control these cookies as the Company in the capacity of data controller.

We utilize some technologies ("cookies") such as cookies, pixels, gifs to improve your experience during your visits to our Website. The use of these technologies is carried out in accordance with the legislation we are subject to, especially LPDD.

#### 1. Method of Collection of Your Personal Data and Legal Reasons

Within the framework of Article 5/2 of the PDPL, your personal data are collected by the Company as the data controller, mandatory and necessary basic cookies and analytical cookies for the fulfillment of our legal obligations, the establishment of the right and legitimate interest grounds; targeting advertising and analysis cookies are collected verbally, in writing or electronically, automatically or non-automatically, through the following and other channels that may be added to them in the future, based on your consent.

# 2. Purposes of Processing Your Personal Data

Your personal data, in line with the purposes specified in the section titled "Purposes of Processing Your Personal Data" of this Clarification Text, provided that the necessary technical measures are taken within the scope of Articles 8 and 9 of the LPDD, (i) to third parties from whom it receives support in areas such as storage, archiving, hosting (server, hosting, program, cloud computing) in order to carry out information security processes, (ii) to Multi Corporation BV and Multi's and Shopping Center Management Company's group companies and service providers located abroad due to the fact that the technical infrastructures are located abroad, and (iii) to legal authorities upon request.

#### 4. Access to Your Personal Data and Your Rights under the Law

Pursuant to Article 11 of the LPPD, your rights are listed below:

- to learn whether personal data is being processed,
- request information if personal data has been processed,

- to know the third parties to whom personal data are transferred domestically or abroad,
- to request correction of personal data in case of incomplete or incorrect processing and to request notification of the transaction made within this scope to third parties to whom personal data is transferred,
- Although it has been processed in accordance with the provisions of the LPDD and other relevant laws, to request the deletion or destruction of personal data in the event that the reasons requiring its processing disappear and to request notification of the transaction made within this scope to third parties to whom personal data is transferred,
- object to the occurrence of a result to the detriment of the person himself/herself by analyzing the processed data exclusively through automated systems,
- to demand the compensation of the damage in case of damage due to unlawful processing of personal data.
